# Minutes of the PEWAMO-WESTPHALIA Board of Education July 15, 2024 7:00 P.M. Regular Board Meeting

President's Call to Order: Meeting was called to order by Vice President Schafer at 7:00 p.m.

Approve the wellness committee members - The State of Michigan requires schools to have a Wellness Committee. Motion made by P. Weber, seconded by T. Anderson to approve the following wellness committee members: Jennifer Goodman, Evan Fedewa, Deborah Prince, P.E. Teacher, Jessica Anthony, Food Service Worker, Monica Newman, Alanna George and Student Representative. Motion carried 5-0.

Approve the Elementary Staff Handbook - The handbook was revised to replace "upper elementary" to "grades 3, 4 and 5". Motion made by J. Pohl, seconded by P. Weber, to approve the revised elementary staff handbook. Motion carried 5-0.

Approve the Middle High School Staff Handbook - Motion made by J. Pohl, seconded by T. Anderson, to approve the Middle High School Staff Handbook. Motion carried 5-0.

Approve the school loan revolving fund annual loan application - As a precautionary measure, Scott Brown recommended P-W applies for this certification in the event it is needed to borrow money to make a bond payment. Motion made by P. Weber, seconded by J. Pohl, to approve the school loan revolving fund annual loan application. Motion carried 5-0.

The consent agenda included the hiring of Trey Bauer, through Edustaff, as the varsity baseball coach. J. Pohl reported the Board had not approved the resignation of our current varsity baseball coach. *Motion made by B. Weber, seconded by J. Pohl, to accept the resignation of Curt Nurenberg as varsity baseball coach. Motion carried 5-0.* 

Motion made by J. Pohl, seconded by B. Weber, approve the recommendation to hire Trey Bauer, through Edustaff, as the varsity baseball coach. Motion carried 5-0.

J. Pohl requested a review of the checks and balances of the credit card usage for school employees. Scott Brown reviewed the process and confirmed many checks and balances are in place.

Approval of the Check Registry ending June 30, 2024 - Discussion was held on the check written to Albin Hengebach Cabinetry with work done on the pressbox, as the Board of Education has not approved this purchase. Discussion was held on if drawings were received and inspections were done and what the board policy is for a spending threshold. J. Goodman stated she would research and update the Board of Education. *Motion made by J. Pohl, seconded by T. Anderson, to approve the check registry.*Motion carried 5-0.
