Approve the recommendation to hire Peri Pung, through Edustaff, as a 8th grade second team volleyball coach - B. Weber expressed questions as if we have a policy to determine when additional teams are created for athletic events. J. Goodman stated when hired, she was told that when a middle school team has more than 20 athletes on a team sport, a second team would be created to allow more students to participate. One suggestion would be to that the coach's salary could be paid via the activity account funds. Recommendation to review Schedule B during the upcoming negotiations to address teams with larger participation numbers. *Motion made by B. Weber, seconded by T. Anderson, to approve the recommendation to hire Peri Pung, through Edustaff, as a 8th grade second team volleyball coach. Motion carried 6-0.*
